Of this amount, \$4.5 billion was provided for the basic grant and \$200 million in contingency funds which have been released.

Of the basic grant amount, \$3.67 billion was allocated under the "old formula" and \$840 million was allocated under the "new formula"

2/ The FY 2012 Consolidated Appropriations Act (PL 112-74) provided \$3.47 billion for LIHEAP of which \$2.974 billion was allocated under the "old" formula and \$497 million under the "new formula".
